## **Do third parties see and/or have access to information obtained by the Application?**

Facebook SDK used only for sharing kid’s achievements on Facebook.

Twitter SDK used for sharing kid’s achievements on Twitter.

Google Rewarded video ads added. TALENE activities can be unlocked by watching rewarded based video Ads. Ads won’t play automatically. User can decide whether to play or not video Ads.

TALENE app won't collect any user information.

### **What are my opt-out rights?**

You can stop using the app by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

### **Data Retention Policy, Managing Your Information**

User can enable/disable push notifications. Other than that no user data collect by TALENE app.

### **Children**

TALENE is created for kids. And TALENE app won't collect any kind of sensitive data from kids. TALENE parents' area where parents can purchase new TALENE items also blocked from kids.

### **Security**

TALENE is created for a single user. No networking features come with TALENE app.
